This Monthly Progress Report (Report) contains a summary of activities that have occurred during the above-referenced month, under the Consent Order for Preliminary Injunction to Conduct a Remedial Investigation and Feasibility Study between Cyprus Amax Minerals Company (Cyprus Amax), et al. and the State of Ohio dated November 3, 2010 (COPI), at the Former Satralloy Site (Site). Reports summarize activities within the monthly reporting period and are submitted to the Ohio Environmental Protection Agency (OEPA) via the OEPA portal by the 10th day of every month. Copies of daily reports, inspection reports, sampling data and laboratory data, etc. will be provided to OEPA upon request.

1. Work Completed

Interim Action

- Slag consolidation operations continued through June, including relocation and placement within the Former Mine Area.
- Daily visible emissions monitoring was completed in accordance with the Fugitive Dust Work Practice Plan and the Permit-to-Install and Operate.
- BMP inspections and maintenance were completed in accordance with the general construction storm water permit.
- Excavation of borrow areas in the Former Mine Area continued with the clean fill transported and placed in the Lowlands to backfill slag removal areas.
- Soil samples for slag removal confirmation were collected from the Lowlands on June 2 and 23, 2026.

RI/FS

- None during this reporting period.

Treatability Study

- None during this reporting period.

General Industrial Storm Water Permit

- None during this reporting period.

General Construction Storm Water Permit

- Weekly BMP inspections and maintenance were completed.

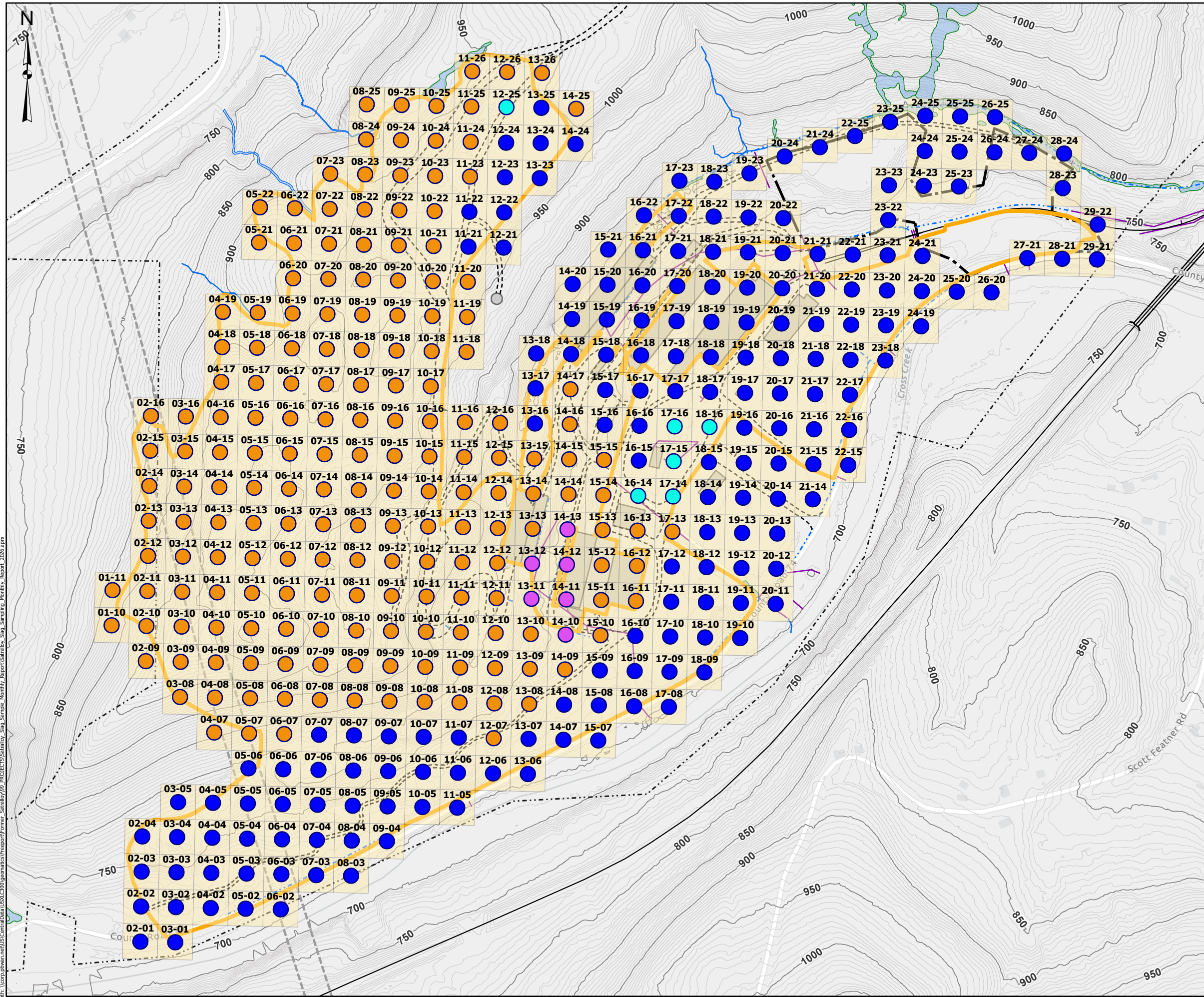
